The Correspondent, Oakridge Educational Society, Karamchedu Road, Perala, Chirala, Chirala Mandal, Prakasam District has submitted the application for Provisional Recognition for classes I to V(EM) for the years form 2018-2019 to 2027-2028 to Pride School (EM), Oakridge Educational Society, Karamchedu Road, Perala, Chirala, Chirala Mandal, Prakasam District in the reference 2nd cited.

The Mandal Educational Officer, Chirala, has verified the application for Provisional Recognition with reference to the conditions laid down in the previous orders and G.O.Ms.No. 1 Edn. Dt. 01-01-1994 and subsequent amendments issued by Government and submitted proposal in the reference 3rd cited. After examination of the proposals submitted by the Mandal Educational Officer in the reference 3rd cited, **Provisional Recognition is hereby accorded for a period of 10 years commencing from the academic year from 2018-2019 to 2027-2028 for classes from I to V (EM) at Pride School (EM), Oakridge Educational Society, Karamchedu Road, Perala, Chirala, Chirala Mandal, Prakasam District** subject to fulfillment of the following conditions.

That the society shall abide by the instructions/rules and regulations made by the Government or authorized Officer from the time to time.

1. That the Educational Institution shall serve the needs of the locality more particularly.
2. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timings vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year.
6. That the records/ accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer, every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer, every year.
9. That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with.
10. That the school shall not be closed without giving notice both to the parents/ District Educational Officer, and competent authority at least six months before.

11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No objection certificate.
14. The management informed that no thatched roof accommodation is allowed to run the school.
15. Proper and adequate sanitation facility shall be provided for students especially for girl students.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the School for the academic year.
22. That the management shall take every responsibility for the timely safety and comfortable mobility of the School Children from the residences to School and vice versa.
23. That the School Van should be ensured road worthy for the transportation/ mobility of School Children.
24. That the School Bus should be free from all taxes due and should be maintained with regular checks by authorized mechanism of periodically/ as and when required without causing any sort of dislocation for the School Children opting the bus facility.
25. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the School Van.
26. That the management shall ensure the vehicle and safety girls be provided to the windows of the Vehicle.
27. That the management shall ensure the Accounts of the School audited by an authorized Chartered Accountant every year and submit.
28. The management shall have to follow the rules and guidelines issued to G.O.Ms No.91/ Edn., dated 06-08-2009 and also the provisions of RTE Act regarding fee structure and in other matters.
29. The management is hereby informed that the recognition is being given purely on temporary basis and is subject to the report of state level inspection and vigilance committee regarding fulfillment of all the pre-requisite conditions under A.P. Education Act 1982 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
30. The Management should Renewal Fire Certificate every year from time to time.
31. The Management should submit an affidavit in April every year to the effect that there is no description of the Govt. order issued from time to time.
33. The Management should appoint the teachers only after passing the TET Exam along with Regular qualification
34. The Management should upload the FEE to be collected for the year 2018-2019 in CSE.AP.GOV.IN Web site and also display in prominent places in The school
35. The Management should be paid Professional Tax as per rules.

If the management fails to comply with the above conditions promptly the Recognition now granted will be cancelled without any notice.
